Cultural Resource Notice An Underused But Important Preservation Tool of the PA Department of Environmental Protection

) ho knows better than we do? We, who live in Chester County's boroughs and townships . . . who wake each morning in century-old houses . . . who cross stone bridges traveling to work . . . who walk our dogs in fields dotted with weathered barns. Who knows better than we the beauty of the built reminders of our common history? And who understands the importance of preserving those resources more than those of us who live among them? Historic preservation is local. Historic preservation is a textbook, grass-roots endeavor that trickled up, capturing the attention of county, state and federal officials.

Today, historic preservation is impacted by a number of separate government agencies, each with unique processes and requirements. CCHPN President Bruce Knapp will open the Workshop at 8:30 am with a brief welcome and the introduction for Longwood Gardens' Executive Director Paul Redman. Paul will discuss the recently completed Route 52 Re-Alignment Project.

Karen Marshall, Chester County Heritage Preservation Coordinator, will introduce the morning's Case Study, a simulated 10-Lot Subdivision Project. Dominic Rocco, a DEP representative, will walk through the DEP permitting process and explain the role of the Cultural Resource Notice, focusing on how the review process works and how results are used at the state level.

Gaye Lynn Criswell of the Chester County Conservation District will discuss the county level review process. Susan Zacher, a Historic Resource Specialist, formerly at

the Bureau of Historic

Preservation, will share her experience coordinating agencies when environmental reviews involve historic resources.

The Workshop will close with what promises to be an energetic Q&A session. Guests will be encouraged to tour the gardens after the workshop.

Who Should Attend?

The Spring Workshop is best attended by Historical and Planning Commissioners. Zoning officers and Township Managers may also be interested. Participants will come away with knowledge that will allow them to effectively partner with State and County agencies as land development projects are proposed in their municipalities.


Longwood Gardens is located on US Route 1, about 3 miles northeast of Kennett Square, PA.

Introducing Our Newest CCHPN Board Members Rob Lukens, Ph.D. & Gail Brown

) ob Lukens, Ph.D.

► Rob's first experience in museums and public history came as a volunteer at Chester County Historical Society (CCHS) nearly twenty years ago. Later, he interned there, and then worked as the organization's Collections Manager from 1998-2003. Following employment at other venues, he returned to CCHS on October 1, 2011, when he replaced Kimberly Hall as the President. Between his times at CCHS, Rob served as Chief Curator and Head of Collections at the Chemical Heritage Foundation in Philadelphia, and from 2005 to 2009, he led Historic Yellow Springs, Inc. From 2009 to 2011, Rob was the Exhibits and Education Director at the U.S. Capitol Visitor Center in Washington, D.C.

Rob is no stranger to Chester County. A former resident of West Chester, he has contributed more than 75 articles on the county's heritage to the *Daily Local* News, an effort he's continuing today on a monthly basis.

In 2011 he received his Ph.D. from Temple University in American History, and portions of his dissertation, researched in the CCHS's collections, were published in Pennsylvania History and contributed to his work as guest curator of CCHS's exhibition Chilling Reality: Chester County's Arctic Explorers, which opened in fall 2010.

Rob was a member of the West Chester Historical and Architectural Review Board, was a Commonwealth Speaker with the Pennsylvania Humanities Council, and is currently on the board of the Chester County Conference and Visitors Bureau.

Rob lives with his wife Rebecca and their two children, Abbie and Finley, in North Wilmington, Delaware, but plans to move back to Chester County

Larry and Gail Brown moved from Williamsburg, Virginia, to East Coventry Township in May of 2003. Gail was recruited by a Township Historical Commission Member, Mrs. Mary Ann Keen, to serve as a volunteer for the summer 2003 Town Tour and Village Walk at Frick's Locks Village. Gail began attending Historical Commission meetings the summer of 2003 and become a member of the Historical Commission when she achieved the one year residency requirement. She served as Historical Commission Chairman from the fall of 2006 through 2009. Gail currently serves as Vice Chairman of the Historical Commission.

Gail also has served as a member of the Frick's Lock's Stakeholders from August 2007 to the present. This partnership between Exelon; Township, County and State Government officials and consultants; the Schuylkill River Greenway Association; and Preservation Pennsylvania has resulted in proposed \$3.8 million rehabilitation by Exelon of Frick's Locks National Register-listed Historic Village.

Gail has attended Chester County Historic Preservation Network-sponsored workshops and events through the years and found them a valuable tool and resource in preservation education and applications

Joshua Sharpless Homestead Listed on the National Register of Historic Places

n December 15, 2011, the Sharpless Homestead was listed on the National Register of Historic Places. The property is located on Birmingham Road in Birmingham Township and in the Brandywine Battlefield National Historic Landmark. It is comprised of four buildings constructed with serpentine stone: a multi-additive farmhouse, stable, smokehouse, and springhouse. The Sharpless Homestead is one of the largest collections of serpentine stone buildings in Chester County.

he second annual Chester County Preservation
Fair is coming on April 21, 2012, at Historic
Yellow Springs, Inc. This conference and trade show is
co-sponsored by CCHPN and HYS and serves to
promote historic preservation and to educate the public
and professional and volunteer preservations, while
highlighting the talents and capabilities of local
tradespeople and service providers. It is the only event
of its kind in Chester County.

This year will feature an two tracks of presentations and demonstrations: "Preserving Our Heritage", focusing on heritage development, planning, and supporting services for owners of historic sites; and "Hands On History," a series of practical demonstrations on such things as window repair, floor repairs and refinishing, and other skills for those who own and work on historic buildings.

The property is significant under Criterion C for architecture in the context of serpentine stone construction in the county. The stone was likely quarried from Brinton's Quarry nearby, the best known serpentine quarry in the county. The house was constructed in several building campaigns, with multiple types of masonry that reflect the development of the use of serpentine as a building material. The northeast section, the earliest phase, was constructed with rubble serpentine stone. The southeast section was constructed circa 1785 and exhibits one face of dressed stones, giving it a formal appearance. The west section was constructed in two campaigns; the earlier stonework (circa 1795) was built with coursed serpentine. In 1860, the west end of the house was built with highly decorative hexagonal stones. The property also includes a stable constructed entirely of serpentine stone: a rarity.

The property appears to have been settled by Abraham Davis, who constructed a house circa 1730. Susannah Davis, a widow, lived here during the 1770s, and during the Battle of the Brandywine the house was called one of the two "Widow Davis" houses.

In 1784, Joshua Sharpless purchased the farm from the Davis family and initiated 133 years of ownership by the Sharpless family. Sharpless was the first important headmaster at Westtown School and played an important role in negotiations with the Indian Chief, Cornplanter, that led to the establishment of the Tunesassa School for Indians in western New York. The western section of the house was constructed during the ownership of Aaron Sharpless, another headmaster at Westtown. A historic sketch of the property was drawn in 1838 by a grandfather of Philadelphia councilman Thatcher Longstreth. Aaron's son, Isaac, the last Sharpless to own the property, was a long-time president of Haverford College.

The following individuals should be noted for their assistance with the nomination: Samuel and Joae Walker, the owners, John Milner, and Jane Dorchester. Unfortunately, Samuel Walker died on November 17 before the property was listed. Wise Preservation Planning, LLC, prepared the nomination with the help of the local supporters. It is the 24th successful nomination drafted by the company.
