LEED is a Green Building Rating System developed by the US Green Building Council that provides a suite of standards for environmentally sustainable construction. Both new construction and renovation/retrofit projects can apply to become LEED-certified by an independent third-party LEED-accredited professional. Currently, LEED standards have been established for:

- New construction
- o Existing buildings: operation & maintenance
- o Commercial interiors
- o Core and shell
- o Schools

- o Homes
- o Retail (in progress)
- o Healthcare (in progress)
- o Neighborhood development (in progress)

Members of the RecycleBank program can earn Points by curbside recycling and recycling e-waste. In the curbside program, your RecycleBank cart will be weighed each week upon pick-up. The weight will then be translated to RecycleBank Points. The more you recycle the more your household can earn. In a few select communities, households earn rewards based on their equal share of the total amount that their entire community recycles.
